The rationale for this request was as follows:

Clanwilliam indicated that they are planning to make significant changes to the programme structure and content to bring it in line with national and international best practice and in consideration of CORU standards for the accreditation of psychotherapy courses. This extension of the timeline for the programmatic review and re-validation of the programme would enable Clanwilliam to carry out a rigorous review and present a coherent proposal for a revised programme that will benefit all their learners. In this regard, Clanwilliam are seeking an additional resource to take on some of the tasks involved in the re-validation process. On a revised timeline, Clanwilliam would hope to be in a position to agree Terms of Reference during the first quarter of 2023 with a view to completion of the re-validation process, including issuing of the Certificate of Validation by June 2024.
